<b>Secretary:</b> KISMA Ferial	(Inorganic products. Acids, hydroxides, salts, oxides, sulfur, industrial gases. Organic products. Acids, alcohols, anhydrides, esters, aldehydes, ketones, phenols, aliphatic hydrocarbons, aromatic hydrocarbons, Halogenated hydrocarbons.)
<b>NTC 28 : Paper industry</b>	<b>Scope</b>
<b>Secretary:</b> KISMA Ferial	(Paper, board and pulps)
<b>NTC 29 : Paints and varnishes</b>	<b>Scope</b>
<b>Secretary:</b> BOUDRIA NACERADINE	(Standardization in the field of paints, varnishes and related products, including raw materials.)
<b>NTC 30 : Plastics</b>	<b>Scope</b>
<b>Secretary:</b> BACHA Soumya	(Standardization of nomenclature, test methods and specifications applicable to materials and products in the field of plastics, excluding rubber and shellac.)
<b>NTC 31 : Fertilizers and soil conditioners</b>	<b>Scope</b>
<b>Secretary:</b> BOUDRIA NACERADINE	(Standardization in the field of fertilizers, soil conditioners and growing media, i.e., products intended to ensure or improve the nutrition of cultivated plants and/or improve soil properties.)
<b>NTC 32 : Petroleum products</b>	<b>Scope</b>
<b>Secretary:</b> BACHA Soumya	(Crude petroleum, Liquefied petroleum gases, Petroleum products in general, Liquid and liquefied hydrocarbons, Motor fuels, Aviation fuels, Marine fuels, Lubricants, Waxes, Bituminous products, Insulating oils.)
<b>NTC 33 : Glass and abrasives</b>	<b>Scope</b>
<b>Secretary:</b> KISMA Ferial	(Laboratory glassware, flat glass, hollow glass excluding packaging aspects, glass mirrors, windscreens, glass blocks, bonded abrasives, coated abrasives.)
<b>NTC 34 : Surface active agents and maintenance products</b>	<b>Scope</b>
<b>Secretary:</b> KISMA Ferial	(Standardization of classification, terminology, sampling, physical, chemical or other test methods, specifications, etc. of surface active agents, maintenance products and mixtures containing one or more surface active agents with or without other usual soap components and detergent compositions.)
<b>NTC 50 : Adhesives</b>	<b>Scope</b>
<b>Secretary:</b> BOUDRIA NACERADINE	(Standardization of terms and definitions, test methods and specifications for adhesives and glues in any form.)
<b>NTC 52 : Gaz Naturel</b>	<b>Scope</b>
<b>Secretary:</b> BOUDRIA NACERADINE	(Standardization of terminology, quality specifications, designation, measurement, sampling, analysis and test methods in the field of natural gas, liquefied gas and natural gas substitute products. Coordination of work on natural gas carried out within other Technical Committees, excluding liquefied petroleum gas which falls under the scope of Technical Committee 32 "Petroleum products and lubricants".)
<b>NTC 53 : Materials, equipment and offshore structures for petroleum, petrochemical and natural gas industries</b>	<b>Scope</b>
<b>Secretary:</b> BOUDRIA NACERADINE	(Standardization of materials and equipment used in the drilling, production, refining and pipeline transportation of petroleum and natural gas).
<b>NTC 55 : Phytosanitary products</b>	<b>Scope</b>
<b>Secretary:</b> BOUDRIA NACERADINE	(Standardization of common names for phytosanitary products and related substances including test methods. Standardization of pesticides and other agrochemical products.
